Your Impact, By the Numbers

Because of you, in 2025, the Center for Independence remained strong, stable, and focused on what matters most. Together, we generated \$2.5 million in total support and revenue and provided more than \$1.2 million in charitable care—so every child and family could access services regardless of their ability to pay.

December 31, 2025 Financial Summary

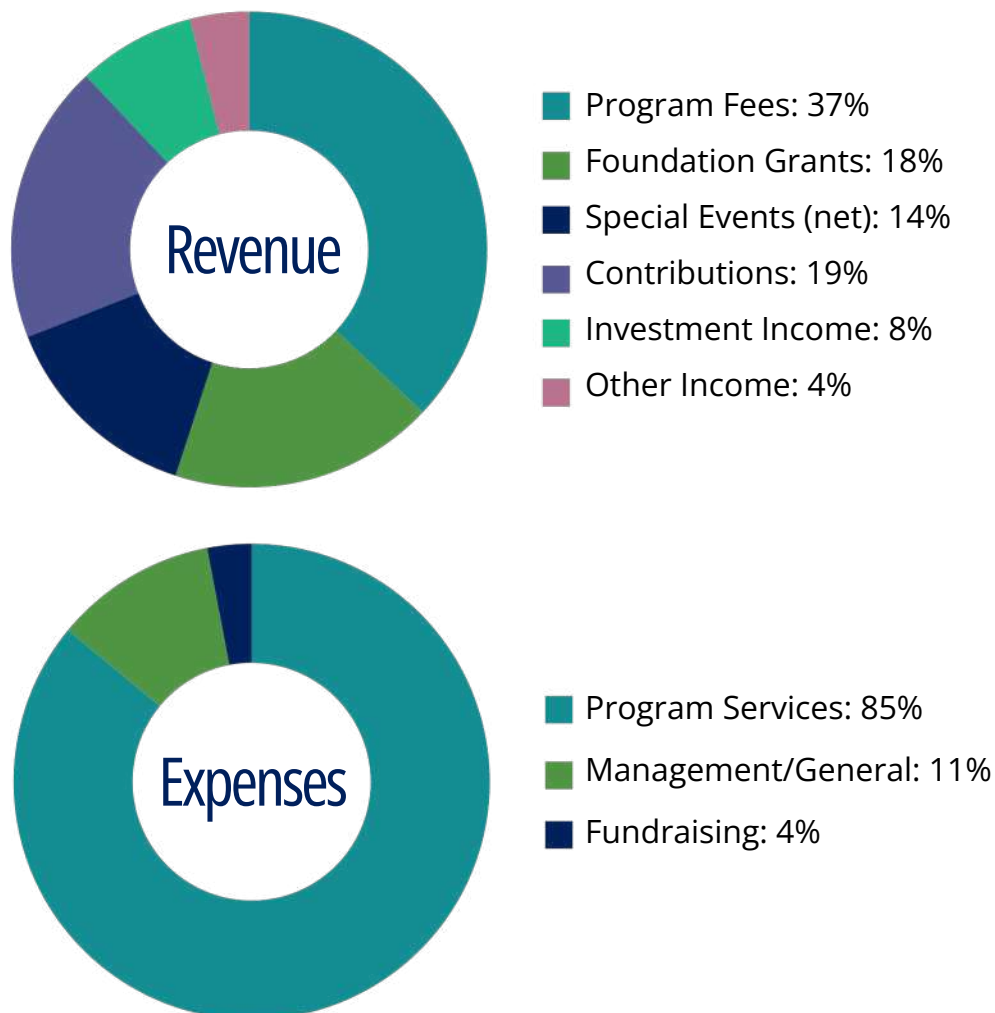
Total Revenue: \$2,543,508

This year's revenue included two one-time items: a \$153,000 Employee Retention Credit from 2021 and a generous \$215,000 anonymous estate bequest. With \$2.61 million in net assets, the Center is well-positioned to sustain its impact and continue growing to meet the needs of more families.

Advanced educational outcomes! 75% of preschoolers and kindergarteners transitioned to regular education classrooms, far exceeding the national average for children with multiple disabilities.



Prepared 100% of therapy participants to graduate from high school, with 50% of graduates enrolling in college courses



Delivered over \$1.2 million in charitable care, ensuring no family was turned away due to financial hardship



Hosted 18 free Parent Education Workshops, giving families tools to support their children's growth and development

Jake came to Working Together Chicago with a clear goal: a full-time job with benefits and a place of his own close to work. After starting in high school at Domino's, he was ready for more. Following multiple leads and interviews, Jake and the WTC team secured a position at FedEx as a package handler—despite the challenge of a 3 a.m. shift.

Jake embraced the opportunity. Today, he works nearly 40 hours a week, often picks up extra shifts, and has proudly moved into his own place within walking distance of work.

Healthy Mothers, Healthy Families (HMHF) Program!

Three occupational therapists from the Center have begun specialized training with Dr. Helen Bourke-Taylor, OT, PhD, learning about Health Promoting Activity Coaching as part of the Health Mothers Healthy Families initiative at the Center.

After several weeks of training and coaching, the occupational therapists will earn their Coaching Certificates. HMHF equips mothers of children with disabilities with the tools to build sustainable home and family routines that support health, well-being, and balance.

Research shows that when caregivers' mental health is supported, both their quality of life and the care they provide to their children improve. Through evidence-based mental health interventions and Health Promoting Activity Coaching, the Center strengthens the overall health and well-being of mothers and their families.
